RETURNING STUDENT SCHOLARSHIPS

1. **ACANTILADO SCHOLARSHIP:** Eligible applicant must be a graduate from St. Joseph High School in Hilo, Hawaii. If no student meets this criterion then any student from Hawaii would be eligible. They must be of outstanding moral character with a 2.0 GPA. Must provide two letters of reference.
2. **ALOHA SCHOLARSHIP:** Eligible applicant must be a female student from the state of Hawaii, who demonstrates financial need as determined by the Financial Aid Office. Eligible students must receive a letter of support from their parish priest. Recipient must maintain a 3.00 GPA to remain eligible for renewal of the scholarship. Student must be full time.
3. **AMSBERRY/PILLIOD ENDOWED SCHOLARSHIP:** Eligible applicant must demonstrate financial need as determined by the Financial Aid Office.
4. **ANTEKEIER SCHOLARSHIP:** Eligible applicants must be from a family with six or more dependent children with financial need as determined by the Financial Aid Office.
5. **ARKANSAS SCHOLARSHIP:** Eligible applicants must be residents of Arkansas with financial need and at least a 3.0 GPA. Applicant must be Catholic and willing to make a moral commitment to live and work in Arkansas upon graduation. Undergrads must major in Education, HCC, Mental Health and Human Services, Philosophy, Social Work, or Theology. Theology must be minor, if not major. Grad Students must major in Theology, Philosophy, Counseling, or Education.
6. **BEDWAY, PHOEBE SCHOLARSHIP:** Eligible applicant must be a female student preparing for a career in business.
7. **BERKMAN, LOUIS SCHOLARSHIP:** Eligible applicants would be any student who has been raised in the local (Tri-State) area. Student must have financial need as determined by the Financial Aid Office and a minimum GPA of 2.5.
8. **BETTWY, SR ISABEL SCHOLARSHIP:** Eligible applicants must be any student who demonstrates a Christian commitment and openness to the Holy Spirit and has exhausted all other possible sources of financial assistance and must maintain a 2.5 GPA.
9. **BLACKBURN, FRANK AND BESSIE C. SCHOLARSHIP:** Eligible applicants must be from the local area, with preference being given to graduates of SHS and CCHS. Applicant must show financial need. A 2.75 GPA is required to be eligible for renewal.
10. **BLESSED JUNIPERO SERRA SCHOLARSHIP:** Eligible applicants must be enrolled in the University's Pre-Theologate Program with at least a 2.75 GPA and demonstrate financial need as determined by the Financial Aid Office.
11. **BROWN, H.G. MEMORIAL SCHOLARSHIP:** Eligible applicant must be a nursing major who has a financial need as determined by the Financial Aid Office.
12. **BURKEMPER, DIANE SCHOLARSHIP:** Eligible applicant must be a student majoring in Theology, with financial need as determined by the Financial Aid Office.
13. **BURNS, GENEVIEVE MEMORIAL SCHOLARSHIP:** Eligible applicants must live in the greater Iowa City area (Johnson, Iowa, Boone, and Story counties).
14. **CALLAGHAN, WILLIAM JR. MEMORIAL LEADERSHIP SCHOLARSHIP:** Eligible applicants must exemplify leadership qualities in the classroom, as well as in extra-curricular activities, and must be well formed in all areas of mind, body and spirit.
15. **CALLAIS FAMILY, HAROLD AND GLORIA SCHOLARSHIP:** Eligible applicant must be enrolled in the University's Pre-Theologate Program and planning to enter the priesthood.

17. **CARRIGG, JOHN J. SCHOLARSHIP:** Eligible applicant must be a full-time sophomore, junior, or senior majoring in History. Must maintain a 3.5GPA and must write an essay (no more than two pages) responding to the question, "What will I do with a degree in history?"
18. **CHAGARES, ELIZABETH MARY MEMORIAL SCHOLARSHIP:** Eligible applicant must be a full time student enrolled in the Nursing Program and in good academic standing.

21. **CONFORTI-ALEAGA FAMILY SCHOLARSHIP:** Eligible applicant must be enrolled in the University's Pre-Theologate Program and maintain a minimum 2.75 GPA.
22. **COSMAS AND DAMIAN PHYSICIAN SCHOLARSHIP:** Eligible applicant must be a junior or senior enrolled in the Pre-Medicine Program and maintain a 3.0 GPA.
23. **D'ANNIBALLE, ANTOINETTE SCHOLARSHIP:** Eligible applicants must be pursuing a BS in nursing and have demonstrated financial need.
24. **D'ANNIBALLE, ROBERT J. SCHOLARSHIP:** Eligible applicant must be a resident of Jefferson County, Ohio and may be enrolled full-time, part-time, day or evening. First preference given to registered nurses graduating from Trinity Medical Center School of Nursing and attending Franciscan University's BSN or Masters in Nursing programs. Must have financial need.
25. **DAVIES, MARY JANE & BRUCE SCHOLARSHIP:** Eligible applicant must be a Political Science major or pursuing a career in government. Must demonstrate financial need and maintain a 2.5 GPA.
26. **DINOVO, PIETRO AND SON SCHOLARSHIP:** First priority for this scholarship will be given to family members of employees of DiNovo and Sons. Secondly, it will be offered to residents of Jefferson County, OH. Finally, applicant can be a residents of Brook and Hancock Counties, WV. Must maintain a 2.0 GPA.
27. **EGAN, BERTHA SCHOLARSHIP:** Eligible applicants must be permanent residents of Steubenville, having completed High School in Steubenville. Applicants must also have financial need as determined by the Financial Aid Office.
28. **BISHOP EGAN HIGH SCHOOL SCHOLARSHIP:** Eligible applicants must have graduated from Conwell-Egan High School in Fairless Hills, PA. The recipient(s) must maintain a 3.0 GPA to be considered for renewal.
29. **FETYKO FAMILY MEMORIAL SCHOLARSHIP:** Eligible applicant must be a junior or senior enrolled in the Pre-Theologate Program.
30. **FRANCISCAN FRIARS FUND:** Eligible applicants must be full-time. Graduate students must maintain a minimum of 9 hours per semester. Applicants must demonstrate financial need and exhibit a certain level of academic merit, as determined by the Financial Aid Office.
31. **FRAUENHOFFER, KRISTOF P. MEMORIAL SCHOLARSHIP:** Eligible applicant must be an undergraduate enrolled in the Pre-Med program with intention of attending medical school upon graduation from Franciscan University. Applicant must also demonstrate financial need as determined by the Financial Aid Office and write an essay of 750 to 1500 words. *** See Financial Aid Office for the essay topic.
32. **GAR SCHOLARSHIP:** Eligible applicant must be a resident of Ohio residing in Summit county or any of the counties adjoining Summit.

54. **PACIOLI, BR. LUCA-ACCOUNTING/BUSINESS/ECONOMICS SCHOLARSHIP:** Eligible applicants must be students in one of these programs with at least a 3.0 GPA. Recipient must demonstrate financial need. Recipient must demonstrate a personal commitment to a high standard of ethical behavior, honor and integrity. Recipient must also demonstrate the potential for high academic achievement and strong business acumen. Consideration will also be given to students enrolled in the MBA program.

Recipient(s) must demonstrate financial need in accordance with university guidelines and FAFSA regulations. Recipient(s) must maintain a 2.50 GPA.
68. **ST. BENEDICT THE MOOR SCHOLARSHIP:** Applicants must be African-American males who have been accepted by the Office of Admissions and into the University's Pre-Theologate Program.
